



#### I. Qualifications for Application

The application qualifications are based on the Ministry of Education's "Regulations for Foreign Students Studying in Taiwan". If the regulations are revised, the announcement of the Ministry of Education shall prevail. For the latest information on the measures, please refer to the Ministry of Education website.

#### I > Foreign student status

- (I) Never studied in Taiwan as an overseas Chinese student.
- (II) Not distributed by the Overseas Joint Admissions Committee in accordance with the Overseas Chinese Students Returning to China for Study and Guidance in the year of application for admission.
- (III) Those who have foreign nationality and meet the following requirements, and have lived overseas for more than 6 years at the time of application, can also apply for admission:
- 1. Those who have the nationality of the Republic of China at the time of application should have never had household registration in Taiwan from the beginning.
- 2. Those who had both the nationality of the ROC before the application and no longer have the nationality of the ROC at the time of application shall have passed 8 years from the day when the Ministry of the Interior approved the loss of the nationality of the ROC to the time of application.
- 3. The first two paragraphs shall comply with the provisions of the first and second paragraphs of the preceding paragraph.
- (IV) Pursuant to an educational cooperation agreement, foreign as ationals who are recommended by foreign governments, institutions or schools to study in Taiwan, and who have never had a household registration in Taiwan, may not be subject to the restrictions of the preceding two paragraphs upon approval by the competent education administrative authority.
- (V) The 6 years stipulated in the preceding two items shall be calculated with the start date of the current semester (February 1 or August 1) the end date.
- (VI) The term "overseas" in the preceding two items refers to countries or regions other than the mainland, Hong Kong, and Macau; the term "continuous residence" refers to foreign students who stay in China for less than 120 days per calendar year. If the startto-end year of the counting period of continuous residence abroad is not a complete calendar year, it is determined that the period of stay in China within the counting period of each year does not exceed 120 days. However, this is not the case for those who meet one of the following circumstances and have relevant certification

- documents; their stay in China will not be included in the calculation of their overseas residence period:
- Attend overseas youth technical training classes organized by the competent authority for overseas Chinese affairs or technical training classes recognized by the Ministry of Education.
- 2. Attended the Chinese language centers of colleges and universities approved by the Ministry of Education to enroll foreign students for less than 2 years in total.
- 3. For exchange students, the total exchange period is less than 2 years.
- 4. Internship in Taiwan with the permission of the central competent authority for the target industry, and the total period of internship is less than 2 years.
- (VII) Those who have both foreign nationality and ROC nationality, and have applied for loss of ROC nationality before the amendment of the Ministry of Education's "Foreign Students Studying in Taiwan Measures" on February 1, 2009, can apply for admission in accordance with the original regulations. Subject to the provisions of the second paragraph.
- (VIII) Possess foreign nationality, have permanent residence status in Hong Kong or Macau, and have no household registration in Taiwan, and have lived in Hong Kong, Macau or overseas for more than 6 years at the time of application.
- (IX) Those who used to be citizens of the mainland area with foreign nationality and have never had household registration in Taiwan, and have lived overseas for more than 6 years at the time of application.

According to Article 2 of the "Nationality Law of the Republic of China", a person who falls under any of the following circumstances is a citizen of the Republic of China:

- (1) The father or mother was a national of the Republic of China at the time of birth.
- (2) Born after the death of the father or mother, the father or mother was a national of the Republic of China at the time of death.
- (3) Born in the territory of the Republic of China, the parents are untestable, or both are stateless.
- (4) Naturalizers.

#### II > Educational background

(I) Foreign students must be graduates of high schools, universities or independent

- colleges recognized by the Ministry of Education; applicants for bachelor programs must have foreign high school diplomas, and applicants for master programs must have university diplomas.
- (II) Possess the equivalent academic qualifications of the Ministry of Education's "Equivalent Academic Ability Recognition Standards for Entrance Universities" and the educational system in my country.
- (III) Holders of foreign or Hong Kong or Macao academic qualifications must also meet the relevant provisions of Article 9 of the Ministry of Education's "Equivalent Academic Ability Recognition Standards for Entrance Universities".
- (IV) Overseas graduates of the fifth-grade secondary school system, whose graduation grade is equivalent to the second grade of senior high schools in Taiwan, or graduates of similar schools of the same level in Hong Kong and Macau may apply for the bachelor's program of the school. However, after admission, according to the regulations of the school, at least 12 graduation credits should be completed within the prescribed period of study.

#### VII. Notes for Special Attention

- (I) The applicant has never studied in the Republic of China as an overseas Chinese student.
- (II) According to the regulations of the Ministry of Education, foreign students who have admitted to the school due to their conduct, failed academic performance, or expelled due to a criminal case are not allowed to apply for admission to this school again in accordance with the "Regulations for Foreign Students to Study in Taiwan". Those who violate this regulation and verified to be true will have their admission qualification revoked.
- (III) The visa is issued by the Chinese embassy abroad, and the admission permit does not guarantee the obtaining of the visa. Please refer to the website of the Ministry of Foreign Affairs (<a href="http://www.boca.gov.tw">http://www.boca.gov.tw</a>) for visa application procedures for people from certain countries to come to Taiwan.
- (IV) If, after being registered for admission, during the period of schooling, it is allowed to set up household registration, household registration, naturalization or return to the Republic of China nationality during the school period, that is, the foreign student status will be lost and the school will be withdrawn.
- (V) For students who have already registered or admitted, if it is found that the application qualifications do not meet the requirements or the submitted documents are altered, forged, borrowed, or fraudulently used, etc., the admission qualification will be cancelled for those who have not enrolled; those who have already enrolled will be expelled. Students will not be issued any academic certificates; if they are discovered after graduation from the school in the future, they will be ordered to cancel their degree certificates, and their graduation qualifications will be cancelled by announcement.

The foreign insurance certificate should be verified by the overseas embassy (if there is no certificate, the group foreign student health insurance should be insured for six months after arrival in Taiwan).
- (III) According to the provisions of Article 5 of the school's school rules, new students who are unable to enroll in the semester due to pregnancy, childbirth, raising children under the age of 3, serious illness, military service or other reasons of force majeure

may submit relevant certificates to the school before the registration date. If the Academic Affairs Office applies to retain the admission qualification, the admission can be postponed after approval, but the postponement time is limited to one year, and no fee is required.



#### **Traffic information**

#### Taipei Mass Transit:

From the Greater Taipei area, take the 2088, 1579 express bus, Guoguang Passenger Transport, Keelung Passenger Transport, Fuhe Passenger Transport, Pan Air Transport and train to Keelung City.

※Free student bus travels from Keelung Railway Station to and from the campus of our school within about 15 minutes (no service on holidays).

\*During classes, student-only buses depart from Keelung City Bus Terminal and the school in both directions every day.

#### City transfer station:
